What personal data we collect and why we collect it

Comments

When visitors leave comments on the site we collect the data shown in the comments form, and also the visitor's IP address and browser user agent string to help spam detection.

An anonymized string created from your email address (also called a hash) may be provided to the Gravatar service to see if you are using it. The Gravatar service privacy policy is available here: <https://automattic.com/privacy/>. After approval of your comment, your profile picture is visible to the public in the context of your comment.

Media

If you upload images to the website, you should avoid uploading images with embedded location data (EXIF GPS) included. Visitors to the website can download and extract any location data from images on the website.

Contact forms

Cookies

If you leave a comment on our site you may opt-in to saving your name, email address and website in cookies. These are for your convenience so that you do not have to fill in your details again when you leave another comment. These cookies will last for one year.

If you have an account and you log in to this site, we will set a temporary cookie to determine if your browser accepts cookies. This cookie contains no personal data and is discarded when you close your browser. When you log in, we will also set up several cookies to save your login information and your screen display choices. Login cookies last for two days, and screen options cookies last for a year. If you select “Remember Me”, your login will persist for two weeks. If you log out of your account, the login cookies will be removed.

If you edit or publish an article, an additional cookie will be saved in your browser. This cookie includes no personal data and simply indicates the post ID of the article you just edited. It expires after 1 day.

Embedded content from other websites Articles on this site may include embedded content (e.g. videos, images, articles, etc.). Embedded content from other websites behaves in the exact same way as if the visitor has visited the other website.

These websites may collect data about you, use cookies, embed additional third-party tracking, and monitor your interaction with that

embedded content, including tracing your interaction with the embedded content if you have an account and are logged in to that website.

How long we retain your data

If you leave a comment, the comment and its metadata are retained indefinitely. This is so we can recognize and approve any follow-up comments automatically instead of holding them in a moderation queue.

For users that register on our website (if any), we also store the personal information they provide in their user profile. All users can see, edit, or delete their personal information at any time (except they cannot change their username). Website administrators can also see and edit that information.

What rights you have over your data

If you have an account on this site, or have left comments, you can request to receive an exported file of the personal data we hold about you, including any data you have provided to us. You can also request that we erase any personal data we hold about you. This does not include any data we are obliged to keep for administrative, legal, or security purposes.

Where we send your data

Visitor comments may be checked through an automated spam detection service.

Recipients Of Personal Data

Your personal data may be communicated to Liga Nacional de Fútbol Profesional holder of TAX ID G-78069762, with registered office at calle Torrelaguna 60, 28043 Madrid and LaLiga North America with registered office at 423 W 55th Street, 11th Floor New York, NY, 10019, (hereinafter, “LaLiga”) so they can send you commercial communications through any means, including electronic or equivalent means of communication (such as email, SMS, MMS and similar) about the activities, products, services, competitions, offers and/or promotions from LaLiga, the clubs or affiliated SADs that comprise it, or competitions, offers and/or promotions run in collaboration with the official sponsors, which you can view here <http://www.laliga.es/patrocinadores> (hereinafter, the “Official Sponsors”), or promotions organised jointly with third parties such as national and international television channels, as long as you give your express, specific consent by checking the boxes provided.

You have been informed that your personal data shall be included in an automatized file owned by LaLiga, as you authorize that the personal data supplied to LaLiga shall be used for the purposes set out above. LaLiga shall preserve your personal data for the time it needs them for the ends stated in this authorisation and to fulfil its legal obligations. It shall further store them as long as you do not revoke your consent, and/ or do not exercise rights to erasure, objection or restriction of processing.

In this connection, we inform you that following the fulfilment of the purposes for which your data were collected, or once you have exercised the

rights set out above, LaLiga shall keep your personal data duly blocked for a term of five (5) years solely to respond to liabilities of any kind which may arise. These personal data shall be erased when these liabilities expire.

Likewise, you are informed that the legitimate basis for the notification of your data is the consent granted to LaLiga, and that LaLiga shall not supply the personal data to any third parties for its own purposes.

You can exercise rights of access, rectification, objection, erasure, portability and restriction of processing at any time, or revoke your consent to LaLiga, by following the instructions set forth below: An email must be sent to: lopd@laliga.es. No consideration whatsoever shall be requested to exercise the rights.

Revoking the consent granted shall not affect the lawfulness of the processing, based on such consent prior to its withdrawal.
